Dawn Violence Services

Dawn Center has many different programs in the organization that provide services to our community.

- * We are most recognized for our Emergency Shelter Program where we provide services to more than 350 survivors of domestic and sexual violence and their children per year.
- * Our 24-Hour Crisis Hotline is available for survivors of domestic and/or sexual violence. The hotline is staffed by certified advocates around the clock to provide safety planning, crisis counseling, information, referrals, and support.
- * Advocates in our Outreach Program assist survivors of domestic and sexual violence in a nonresidential setting providing support groups and individual crisis counseling to approximately 1.000 survivors per year.
- Our Legal Advocates support survivors through the process of filing for injunctions (restraining orders), provide support and advocacy when going to court, and provide referrals to our local legal aid program for legal advice.
- * Hernando County and Dawn Center is now home to a Sexual Assault Response Team. Victims of sexual assault no longer have to go to Tampa for forensic exam services. Certified examiners are available 24/7 to assist victims, even those who aren't yet ready to make a law enforcement report!
- * Dawn Center provides Primary Prevention Programming to the youth in our community via schools, libraries, youth groups, and more. This helps to ensure our future generation is aware of how to have healthy relationships and other issues

surrounding violence prevention. Community Awareness and Prevention programming reaches approximately 4,000 community members per year.

* Dawn Center's CPI Project builds the capacity of the child welfare system to work with survivors of domestic violence and links victims to much needed services. Using the Safe and Together framework, Dawn Center has collaborated with the Department of Children and Families, Kid's Central Inc., Children's Home Society, Hernando County Sheriff's Office, the State Attorney's Office, and Devereux to help keep families safe.



What this *real* participant in Dawn Center programs had to say...

" I love animals and I rescued a puppy just a few months ago and could tell it was time to leave my abusive situation when my dog was cowering and peeing on himself every time my abuser came home. I found marks on the dog's nose and knew he was being abused. We left our home and slept in the car for two nights until I found Dawn Center. I wasn't going to enter any shelter where I couldn't bring him. My dog literally licked the tears from my face those nights in the car and since arriving at Dawn Center he is a different dog. He is happy, running and playing with me and the other residents. The kids are enjoying it too. When people like me are in abusive relationships, leaving a pet behind is like leaving a child behind and many survivors would never do it. I had another dog in the past that went "missing" and I fear I know what happened

to it...never again. I am so glad I have found Dawn Center and am thankful for the shelter, for the women, children, and the kennel for our beloved pets."

Why denim? Denim Day was originally triggered by a ruling by the Italian Supreme Court where a rape convict overturned because the Justices felt that since the victim was wearing tight jeans she must have helped her remove her jeans, thereby implying consent. The following day, the women in the Italian Parliament came to wearing jeans in solidarity with the victim. Denim Day was developed in response to this case and wearing jean this annual event has become a symbol of protest against erroneous and destructive attitudes about sexual a Women of the Italian Legislature protested the decision by wearing jeans to work. As news of the decision spread the protest. In April 1999, a social service agency in Los Angeles established the first Derim Day in the United and there have been annual campaigns nationally since then.

Twnety Minutes of Rape

In March of 2016, 20-year-old Brock Turner was convicted of three felony counts: sexually penetrating an unco person with a foreign object; sexually penetrating an intoxicated person with a foreign object; and assault with a to commit rape.

Despite the finding of guilt and the brutal details of the crime—which involved a college party, an incapacitate unconscious victim, and bystanders intervening when they discovered the victim behind a dumpster not far from —Judge Aaron Perksy decided to impose a sentence of only six months. This sentence was far less than the s recommended by prosecutors, and only one-quarter of the normal two-year minimum sentence. Persky avo minimum sentence by finding that "unusual circumstances" existed.

Dawn Center staff and supporters signed the petition in outrage against the reduced punishment.

Supreme Court Affirms That Even 'Reckless' Domestic Abusers Should Lose Gun Ri

The Supreme Court ruled in a decision announced Monday that a domestic violence assault commit "recklessly" qualifies as a misdemeanor crime of domestic violence, and therefore triggers the federal ba ownership.

"A person who assaults another recklessly 'use[s]' force, no less than one who carries out that same a knowingly or intentionally," wrote Justice Elena Kagan, who authored the majority opinion. She was joir Chief Justice John Roberts, as well as Justices Anthony Kennedy, Ruth Bader Ginsburg, Stephen Brey Samuel Alito. See full story here
